The Waco Massacre of April 19, 1993.

Defacto U. S. President Bill Clinton and U.S. Attorney General Janet Reno claim 81 Branch Davidian Church members, burned down their own Church, and then killed themselves.

They put the few survivors on trial, and threw them in prison for 40 years.
