## Rev. Lindsey Williams and Jonathan May

**Rev. Williams:** ..A number of months ago, I met a gentleman by the name of John Bergan. John Bergan is an outstanding businessman of Minneapolis, Minnesota. He is quite well-to-do and owns one of the largest nut importing firms of America. John Bergan is very well respected in Minneapolis and is a very reputable individual, not a novice by any stretch of the imagination. He has political clout and when he goes to Washington, even though Minneapolis and Minnesota are very liberal, even the liberals listen to him.

John Bergan said to me some while back, "Lindsey, you need to know a gentleman by the name of Jonathan May." I said, "Who is Jonathan May?" I had never heard his name.

He said, "Jonathan May is a citizen of England." And he said, "Jonathan May has traveled extensively world-wide, knows the issues, became quite knowledgeable through certain sources in the Council of Foreign Relations and the Trilateral Commission as to what the Internationalists intend to do worldwide. It so disturbed him, and having certain Arab sources that he knew, he decided that he would attempt to counteract the game plan of the Internationalists.

Now, the Internationalists are the ones that I attempt to describe in my latest book, *Syndrome of Control*, a group of power elite individuals, probably no more than 12-15 people, who hold the purse-strings of every nation of the world and control most of the governments of the world through the control of their finances. He found out what these individuals were doing and it so startled him until he decided that he would counteract what they were doing by establishing a world-wide Federal Reserve. (You do recognize, of course, that the Federal Reserve system controls the money, the interest rate, the general economy, your lifestyle and mine, of every person in America. It is not an agency of the Federal government.)

So Jonathan May decided he would establish a world-wide Federal Reserve in order to help save certain nations. He got the Arabs to invest multi-amounts of money. I cannot name the exact figure, you'll hear him give some of it himself tonight in his own words. The Arabs had already said 'we will be involved.'

At the point that the Arabs were to deliver the funds in order to start this new creature, Internationalists in England found out about it. They threatened the life of Jonathan May and would not allow the Arabs to transfer the money into England for him to start this. At that point Jonathan May felt that his life was in jeopardy and he came to America. He did the wrong thing, of course, because the exact same powers-that-be that control England, likewise control America. In August of 1980, Jonathan May was arrested and put in Federal prison in Minneapolis, Minnesota, on erroneous charges.

John Bergan put me in touch with him by telephone because I was not allowed to go to the Federal prison. Jonathan May, after numerous conversations, and a lot of persuasion, agreed to allow me to tape a conversation over the telephone that you'll hear parts of tonight.

In this conversation, he tells the game plan, timetable and the inner manipulations of the power elite of the world because of certain sources that he had. He gives the story of what happened to him. The 20-25 minute tape that we're going to be listening to in sections tonight and an explanation with almost every statement you're going to find it very unique, different, startling and possibly very, very disturbing in some senses yet information-wise will probably be some of the most in-depth information that you or I have ever heard.

**Jonathan May:** In 1981, I was exposed to trying to help the Hunt brothers in Texas because they, with John Connelly, who was then governor of Texas, and who was also then, the Under Secretary of the Treasury, had secretly tried to implement a new currency for Texas since Texas is only a part of the union by treaty which is automatically renewed every year but not necessarily automatically renewed every year. It's become a tradition obviously that it's automatically renewed every year but it's actually *not* automatically renewed every year.

● **Rev. Williams:** Did you know that Texas is not a state by vote, such as other states but a state by treaty? (I see one head shaking here in the front.) Texas is a state by treaty, not by vote. Now, you must know that Texas at one time became very wealthy and independent individuals, such as the Hunt brothers, who years ago were nothing but they were made rich overnight through the wealth of oil in Texas when oil was first struck and became so popular in the early days.

Texas, being the place where the Hunt brothers lived, and John Connelly, being the governor of Texas at one time and you remember was in the limousine with John F. Kennedy when he was shot and they tried to shoot Connelly also and he went down in the floorboard of the vehicle and lived through it to tell it.

Well, there's a story behind why John Connelly was attempted to be assassinated and why the Hunt brothers today are bankrupt men that were multi-billionaires fifteen years ago, were some of the wealthiest men in the world and today (I was just in Dallas, Texas, my wife and I).. An individual, who's a friend of ours, met with the Hunt brothers. They are in court right now, in the process of attempting to stall off financial bankruptcy. They have been bankrupted by the internationalists and the reason that the Hunt brothers are being broken today is because the internationalists knew what the Hunt brothers and Connelly, former governor of Texas were trying to do.

Texas, being a state by treaty not by vote, anytime that Texas wishes to, they could not renew their treaty for that year and could legally secede from the union. And the Hunt brothers and John Connelly knew that Texas had the ability of setting up their own country, having their own currency and being solvent and not under the dictates of the Federal Reserve or the bureaucracy in Washington. They were in the process of gaining a corner on the silver of the world in order to be able to finance a process by which they could overcome the financial bankers.

At that point the Hunt brothers were broken, John Connelly was almost killed and Texas who could have been the only state in the union to fulfill it had some major problems and today Dallas and Ft. Worth, Texas, you ride through the cities and you would vow and declare there was almost a ghost town in certain areas. Store fronts are closed. People have moved out \$150-250,000 homes.

Internationalists became so angry at what Texas had done until they broke the back of the oil industry and the major oil producers of Texas and it was all by a design plan and we go further....

**Jonathan May:** The intention was that Texas was going to create it's own money. The Hunts were in partnership with the Shah of Iran, a German banker, and an Austrian banker. The Federal Reserve board got to hear about it. The Hunts were buying silver irresponsibly because they had one man doing both buying and selling on the same floors in all the exchanges.

Word got out and the result of that was that the German banker was murdered. You may remember the bottom line how the terrorists, at the time, who only actually murdered one person, although a lot of industrialists were captured and held to ransom and there were other things. Only one, actually, man who was the banker ever got murdered. And it was that banker that was partners with the Hunts.

**Rev. Williams:** Hunt brothers of Texas, and a banker were attempting to do this. He said that one was killed, the Shah of Iran was deposed and the Hunt brothers filing for bankruptcy. You see what the internationalists can do when you attempt to thwart their plan.

**Jonathan May:** The Austrian banker was so badly beaten up, he'll never get out of a mental institution. And the Hunts, you know what happened to them, they are virtually bankrupt today, despite the fact they had about \$16 billions in worth at the time.

The Shah was perfectly healthy when he left Iran. He was only declared sick when he arrived in America, held in "protective custody" in U.S. military bases where he was treated.

**Rev. Williams:** The Shah of Iran was in perfect health when he left Iran. When he came here, they saw to it that he died. You know it can be very easily done by chemical and germ warfare. The rest of the story of the deposing of the Shah of Iran is dared to be printed in my latest book, Syndrome of Control. Congressman George Hanson dares to tell the story.

You remember Congressman Hanson was in the House of Representatives in Washington. He heard what was happening in Iran and wanted to investigate. Congress would not let him go. The story is told, by the way, minute by minute, hour by hour in this book for the first time, in copyrighted form, you want to get it and read it for yourself.

He went to Iran, paid his own airline ticket to go over. When he got there, the Khomeini gave him an audience. He said, 'We don't want these hostages anymore than you want us to have them.' That wasn't what we were told by the media, was it?

Khomeini said, 'I would like to give you one half of the hostages to take home with you tomorrow morning, if you will promise to start an investigation into the relationship between Chase Manhattan Bank, Henry Kissinger, and President Carter.'

Congressman Hanson called back to someone in Congress whose name he mentions in this book and says, "I can bring half of the hostages home tomorrow. Would you like me to?" He said, 'I'll call you back tomorrow and tell you.' Would you believe? "America Held Hostage" while he says we'll call you back tomorrow and tell you whether you can bring them back or not?

The next day the call came back. Congressman Hanson was told, "Get on the next airplane, come home, don't bring any hostages with you. Do not do any negotiating. You have no right to speak on the part of the Congress of the United States of America even though you are a Congressmen. Get home immediately.

When he came back, he found out that it was documented, by the way, and placed in the Congressional Record, he found that President Carter knew that the hostages were going to be taken. He knew approximately how long they would be kept. He knew that they were there for a reason. The release of the hostages was not negotiated by the State Department of the United States of America. The release of the hostages in Iran was negotiated by a negotiator of Chase Manhattan Bank in New York.

And the hostages were kept and "America Held Hostage" while the bankers got the Shah's money before he was killed and in turn got much of the money of Iran. Do you wonder that Iran is mad at us today after the shenanigans we pulled to get their money into Chase Manhattan Bank so it could remain solvent, one of the wealthiest institutions in the world, today?

That is what Jonathan May is speaking of. And we continue....
