| <h2>Name is Given</h2> <p>A lawful Given Name is privately recorded, inter vivos, traditionally in a Family Bible</p> | <h2>Name is Registered</h2> <p>A legal Tradename is publicly registered, combining your Given and Family names</p> |
| <h2>ESTATE TITLE (Given Name)</h2> | <h2>CORPORATION (Tradename)</h2> |
| Format is proper grammatical English (i.e. John Henry: of the family Doe, or the unique given estate title John-Henry) | Format is typically all-capitals (i.e. on vessel, gravestone) often with a fictional title (i.e. Mr., Mrs) but can be any first <i>and</i> last name |
| ' <i>Capitis diminutio minima. The lowest or least comprehensive degree of loss of status. Rights of liberty and citizenship unaltered.</i> ' john doe [Black's Law, 2 nd Edition] | ' <i>Capitis diminutio maxima. The highest or most comprehensive loss of status. Changed from one of freedom to one of bondage.</i> ' JOHN DOE [Black's Law, 2 nd Edition] |
| <h2>SOVEREIGN TRUST</h2> <p>Created by the parent(s) of a living soul when a Given Name is gifted in the Law of the Land. At 18 you can claim the Legal Title over your Estate (all property) by becoming the Executor of the Foreign Situs Trust (NAME)</p> | <h2>FOREIGN SITUS TRUST</h2> <p>Formed by legalisation when an artificial NAME is Registered in the Law of the Sea. This Trust splits your Estate (all property), creating a "Legal Title" (controller) for the State, and an "Equitable Title" (user) for you</p> |
| This is a Permanent Trust because you have a lifelong right to claim Legal Title to your Estate | This is a Temporary Trust because you can become "holder in due course" of your Estate |
| Man/woman is Executor/Trustee with Controlling Interest (Holder with control) | NAME is Beneficial Owner with Equitable Interest (Owner with liability) |
| Man/woman is Creditor , with power of Remedy | NAME is Debtor , Surety for national debt |
| State is Beneficiary of this Private Trust (payee) | State is Trustee of this Public Trust (payer) |
| Creditor, Grantor, Executor, National, "unlimited" "abode" "remuneration" "location" | Debtor, Grantee, Beneficiary, Resident, "limited" "residence" "income" "address" |
| This Record is used as Evidence for a Birth Certificate that certifies a Bond issue | This Certificate is certification of a Bond with the World Bank as Settlor of the Trust |
| Includes your birth weight in ounces used to calculate value in tables related to gold | The original Bond becomes a Security that is traded on the Market for your "value" |
| <h2>Sovereign</h2> <p>Man/woman born free on the land and living in the Common Law of the Land</p> | <h2>Foreigner</h2> <p>Vessel trading on the Sea of Commerce under Admiralty/Maritime Law of the Sea</p> |
| This record documented your Estate, which can then be stolen. But it is also an Affidavit of Life and a proof of claim | This registration converts your Estate into a tradeable property and puts you to work for the Foreign Situs Trust via the "NAME" |
| <h2>Inherent Right to TITLE</h2> <p>Potential Holder of your Sovereign Estate</p> | <h2>TITLE Claimed by State</h2> <p>False presumptions, claim and contract</p> |
